- Replacement items provided in warranty repairs/replacements are warranted for the remainder of the original warranty period, or 90 days from invoice of services, whichever is greater.
  Out of warranty repairs are warranted for 90 days.
- Refurbished paint is warranted for 2 years
- Fusion & ToolVox servers & components are warranted under Hosted Cloud service plans only due to continuous electronic advancements and future software upgrades.
- Light bulbs and similar replaceable items, minor adjustments, and custom programming are NOT covered by warranty.
